What do you feel is the most valuable service you provide and why? Well, I am a huge stickler about my transcripts being accurate and timely. I've had the same proofreader for over 20 years and nothing goes out, even if it's ten pages, without being proofed. I try really hard to keep a positive attitude. And even though I've been at it over 30 years, I'll still take the 5:00 doctor jobs. Also, I have mentored four reporters. It is so rewarding when you see them spread their wings and start reporting.

**Biggest witness pet peeve?** When witnesses cut the attorney's questions off continuously. It just makes the day long and miserable. And then, of course, those are the witnesses that speak rapid fire fast and go on for pages.

**Funniest thing you have heard during a deposition or in the courtroom?** We hear funny things all the time, but mine was on a loss of consortium lawsuit. For starters, as I was swearing in the husband, he looked me up and down and said "Yeah, babe." Then he was very vocal about how things weren't going too well in the bedroom anymore. He finally said one more outrageous statement and the attorney looked right at me. He lost it, which caused me to lose it. Then everyone in the room was laughing.
